1. Competition arrangements of Solo/Duet/Trio (Primary Section and Special School Section)

In response to the development of the epidemic, the organiser announced on 17 January 2022 that all competitions of Solo/Duet/Trio of Primary/Special School Section originally scheduled to be held from 11-25 February 2022 will be converted to "Video Mode Competition". According to the Annex 2: 58th Schools Dance Festival "Guidelines of Cancellation of Live mode Competition" of the "58th Schools Dance Festival Competition Information" announced in October 2021, the affected schools can choose to request a refund of the entry fee or instead submit a video of the dance for the "Video Mode Competition" from 18-22 April 2022 (The organiser has announced on 28 February 2022 that the above-mentioned submission period will be postponed to 4-6 July 2022).

2. Competition arrangements of Solo/Duet/Trio (Secondary Section)

In response to the development of the epidemic, the organiser announced on 28 January 2022 that all competitions of Solo/Duet/Trio of Secondary School Section originally scheduled to be held from 19-25 February 2022 will be converted to "Video Mode Competition". According to the Annex 2: 58th Schools Dance Festival "Guidelines of Cancellation of Live mode Competition" of the "58th Schools Dance Festival Competition Information" announced in October 2021, the affected schools can choose to request a refund of the entry fee or instead submit a video of the dance for the "Video Mode Competition" from 18-22 April 2022 (The organiser has announced on 28 February 2022 that the above-mentioned submission period will be postponed to 4-6 July 2022).

3. Competition arrangements of DanceSport (Primary and Secondary Section)

In response to the development of the epidemic, the organiser announced on 9 February 2022 that all competitions of DanceSport originally scheduled to be held from 27 February to 1 March 2022 will be converted to "Video Mode Competition". According to the Annex 2: 58th Schools Dance Festival "Guidelines of Cancellation of Live mode Competition" of the "58th Schools Dance Festival Competition Information" announced in October 2021, the affected schools can choose to request a refund of the entry fee or instead submit a video of the dance for the "Video Mode Competition" from 18-22 April 2022 (The organiser has announced on 28 February 2022 that the above-mentioned submission period will be postponed to 4-6 July 2022).
